Purpose of Collection 收集資料的目的

The personal data provided by you to the Allied Health Professions Council and its Board(s) are to be used for the following purposes in relation to the Allied Health Professions Ordinance (Cap 359) and the subsidiary legislation(s) (Cap 359A, 359B, 359F, 359H or 359J):

- i. for compliance with sections 11 and 14 of the above Ordinance;
- ii. to compile statistics;
- iii. to prepare, maintain and publish the register;
- iv. to process complaints or enquiries;
- v. to send you materials issued by the Allied Health Professions Council and its Board(s); and
- vi. any other legitimate purpose.
