**Updates on Mandatory Continuing Professional Development Scheme  
for Physiotherapists**

You are invited to attend a seminar being hosted by the Education Committee of Physiotherapists Board ("the Board") on the latest arrangement of the Mandatory Continuing Professional Development ("CPD") Scheme, as detailed below:

In line with the legislative amendments to the Allied Health Professions Ordinance, Cap. 359, Allied Health Professions Council has resolved that the commencement of the mandatory CPD scheme linking to renewal of practising certificate for Physiotherapists ("PT") as 1 July 2026. Since then, all registrants are required to fulfill the requirements on mandatory CPD scheme stipulated by the Board, if they wish to renew their practising certificates.

Knowing the importance of the mandatory CPD scheme, the Education Committee of the Board would like to share with you the latest arrangement and obtain your views to adjust the finer details.

Considering the large scale of the seminar, it is co-organised by Hong Kong Physiotherapy Association (“HKPA”) and Hong Kong Physiotherapists’ Union (“HKPU”).
